Utility Trench Dewatering and Foundation Drainage Collector (FDC) Pumping Station - Phase 1 Work -

Construction Work: On or after **December 2019 to July 31st, 2020**

Within the next few weeks, the City of Mississauga will begin the construction of the underground pumping station in your community. This work has been planned in two phases:

Phase One: construction will start in December and all work will take place inside the perimeter of the parkette.

Phase Two: construction at the intersection of Black Walnut Trail and Cactus Gate will start in February. An update at that time will be provided to inform you of the construction impacts.

This project is based on findings from the completed Municipal Class Environmental Assessment (Class EA) study and preliminary design.

Road / Pedestrian Restrictions

- During the Phase 1 construction, all Roads will remain open to traffic. Access to all homes will be maintained.
- The **trail inside the parkette** will remain **closed** throughout the construction. Signage will be posted on-site indicating the closure.

Phase 1 Work Details

- Removal of trees inside the parkette
- Construction of an underground pumping station and sewers
- Clearway Construction Inc. is the contractor



What To Expect During Construction

Impacts	There will be some construction related dust, noise and traffic delays. The City will make every effort to reduce the impacts. We appreciate your patience and cooperation.		
Work Hours	Work will occur between 7:00 a.m. to 7:00 p.m., Monday to Friday. Work after hours and on weekends will be limited and only on an as-needed basis.		
Traffic and Pedestrians	Roads	Roads will remain open to traffic in Phase 1 work. An update notice will be issued to notify of road closures prior to the commencement of Phase 2 construction.	
	Sidewalks	There are no impacts on sidewalks in Phase 1 construction.	
	Trails	The trail inside the parkette will remain closed during construction.	
Transit Service	There is no impact on MiWay Transit in Phase 1 construction.		
	An update notice will be issued to notify bus detour information prior to the commencement of Phase 2.		
Parking	There is no impact to on-street parking at this time. Existing parking by-laws still apply.		
Restoration Works	The parkette will be restored with sod and tree planting. This work will occur after construction has been completed.		
Utility Disruptions	Temporary disruptions to utilities (i.e. gas, hydro, water, telecommunications and cable TV) may be experienced. Every effort will be made to promptly restore service.		

Future updates will be provided should there be changes to the project.
