



Addressing Speed

Several dozen residents attended a townhall meeting I held in late November to address concerns related to speeding on Osprey Boulevard. City traffic operations staff and Peel Police officers provided results on recent traffic surveys and enforcement and took questions and comments from the residents in attendance.

In the short-term, I have committed to requesting increased enforcement of both speeding and stopping compliance at all-way stop intersections as well as initiating traffic studies for additional stop signs at two locations on Osprey. I will also ask Traffic Safety Council to review the roadway in front of St. Edith Stein Catholic School during school entry and dismissal times and provide any recommendations to improve student safety. Longer-term, I have commitOsprey Boulevard was the focus of a townhall meeting where residents heard from and asked questions of traffic staff and police officers about speeding on this street.



ted to having a pedestrian crossover installed at the Lisgar Meadowbrook Trail where it crosses Osprey just east of the bridge similar to the one at Doug Leavens Boulevard. That review is already underway and I have secured the funding for it.

I want to thank the residents for their interest in this matter for the safety of all who live on and near this important minor collector road in our community.



Positive Changes to Development

A lot of work has been done to address concerns raised by residents, city planning staff and other commenting agencies on the draft plan of subdivision for development on the lands west of Ninth Line between Britannia Road and Derry Road. In particular, the density of the big red block on the first draft had a range of 350 to 1,360 units that is now pegged at under 500 units.

The presentation of the plan to Planning and Development Committee members on December 2 will be largely what was presented to the community in October, however I anticipate that this significant change will be highlighted verbally by the applicant. I have also met with senior level staff to discuss coordination of timing with respect to the construction of this development and the widening of Ninth Line.

Even as much progress is being made, the applicant has plenty more work to do before coming back to the public with a revised plan at a future community meeting next spring. Watch my monthly eNewsletters for a date and venue when this meeting is confirmed.

A Balanced Approach to 2020 Budget

As a City and Regional Councillor, I have been involved in budget deliberations for both Mississauga and Peel over the past few weeks as we aim to balance the wonderful quality of life our residents enjoy with affordability of providing those services.

This year has been especially challenging on the Regional portion of the budget due to significant cuts in provincial funding that previously supported several key services offered by the Region. For the past decade or so, the annual property tax increase on the Regional portion of the budget has been below 2%. This will almost certainly be higher in 2020 – despite Council's best efforts to find efficiencies and reduce some services – to make up the shortfall in funding from the Ontario government. The budget discussions will continue into December so it's too early at this point to say what the overall impact on the property tax bill will be for 2020.

Pump Station Tender Awarded

The tender for the construction of both the pump station and trench dewatering system has been awarded to Clearway Construction Inc. These pieces of infrastructure are being constructed to address on a permament, automated basis the issues related to basement flooding experienced by some property owners near the Sixteen Mile Creek.

City staff met with the contractor on November 12 where it was agreed that the best approach would be to start working inside the Cactus Gate parkette this winter to build the pumping station first, and then move on to build the trench dewatering system within the intersection at Cactus Gate and Black Walnut Trail. In light of that, it is anticipated that the intersection will remain open to traffic until February 2020. Staff anticipates that the contractor will mobilize at the parkette the week of December 2; construction notices have been sent out to residents in the area.


